#### Objectives and Investment Policy

The objective of the Sub-Fund is to outperform the EONIA reference indicator, which is representative of the interest rate of the Euroland (i.e. countries having fully incorporated the euro as their national currency).

To achieve that objective, the Sub-Fund mainly invests in financial derivative instruments on currencies and in debt instruments, including up to 20% of its total assets in financial instruments whose value and income payments are derived from and collateralized (or "backed") by a specified pool of underlying asset ("asset-backed securities"), issued by worldwide issuers and listed or traded on regulated markets of any OECD country. Targeted currencies are liquid enough to enable easy access and exit from the position.

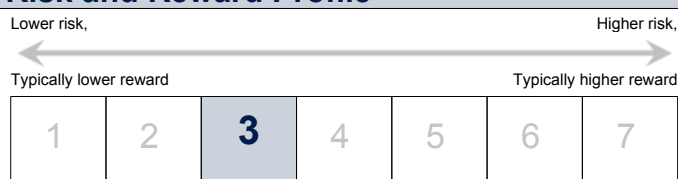
The active management of this Sub-Fund may generate transaction costs that would impact the performance.

The accumulation share automatically retains, and re-invests, net investment incomes within the Sub-Fund when the distribution share pays dividends in September of each year.

The minimum recommended holding term is 1 year.

Shares may be sold or redeemed (and/or converted) on any dealing day (except otherwise stated in the prospectus) at the respective dealing price (net asset value) in accordance with the articles of incorporation. Further details are provided in the prospectus of the UCITS.

#### Risk and Reward Profile



The risk level of this Sub-Fund mainly reflects the investment long and short positions taken in the fixed-income and foreign exchange markets within the pre-defined leeway.

Important risks materially relevant to the Sub-Fund which are not adequately captured by the indicator:

## Charges

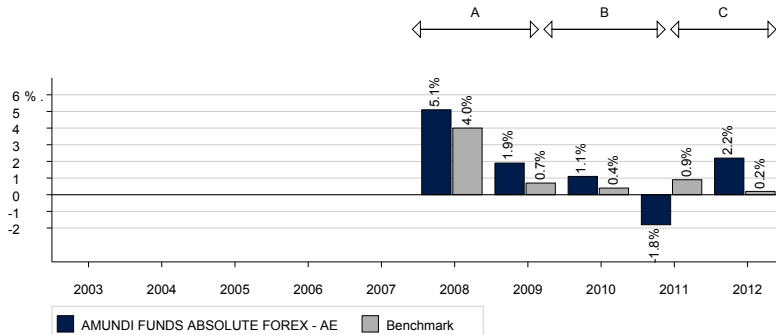
The **entry** and **conversion charges** shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
